- 4) It is the responsibility of the Customer to ensure that sufficient funds are available in the account at the time payment is due.
- 5) It is the Customer's responsibility to ensure that the payment is correctly and timely received by Al-Mizhar American Academy. Al-Mizhar American Academy accepts no liability whatsoever in this respect and is under no obligation to notify the Customer of any outstanding, incorrect, rejected and/or declined payments, whatever the reason.
